

Abbott Farms Herd Share Agreement

Welcome to the Abbott Farms goat milk herd share program! We want your herd share experience to be enjoyable both for you and for us, so before you sign on, please read through this document to learn the terms and conditions of joining the Abbott Farms herd share program. Additional information is available in our herd share fact sheet.

Overview

It is illegal in the State of Michigan to sell raw milk, or even pasteurized milk from a non-Grade A dairy. It is also prohibitively expensive for a small farm to comply with Grade A dairy regulations; thus, we will never be able to sell our milk through conventional channels. However, it is legal for anyone to drink milk from their own animals. Our herd share program allows shareholders to purchase a share of our dairy goat herd, and then receive the milk produced by “their” goats.

Duration

Because of our management methods, we have some goat milk available all year round, with peak production from April to October. We will accept new herd share customers at any time of the year provided we have adequate milk. Each shareholder will agree to purchase a set amount of milk per week during the peak season and will be given the option of getting a reduced amount of milk during the winter or taking several months off.

Prices

To keep things simple for our customers and ourselves, we simply charge \$10.00 per gallon. We will sell as little as a half gallon for \$5.00, or in some cases, even a quart for \$2.50.

Jars

We offer half gallon canning jars for \$3 per jar. You may buy jars from us, or use your own. We do not have disposable jars for milk transport.

Pick-up day and time

Shareholders may select their preferred pick-up day and time; since goats produce a consistent amount of milk throughout the week, we prefer to have our shareholders come on different days to even out demand. Pickups will be Monday through Saturday from 10:00 a.m. to 7:00 p.m.; we do not sell milk or other farm products on Sundays. Please indicate your preferred day and a 2-hour time slot in the space provided below.

Labor Shares

All shareholders have the option to pay part or all of their fees with labor at Abbott Farms, at the rate of \$20/hr. Labor may include weeding and harvesting vegetables, milking goats, feeding poultry, or shoveling manure. Proper training must be conducted for all labor done at Abbott Farms, and Abbott Farms is not responsible for any injuries that may be incurred while shareholders are working at the farm. Abbott Farms reserves the right to decide whether or not to allow each individual shareholder to trade labor.

Liability

Abbott Farms is not liable for any injury or health problems that may result from drinking raw milk. By signing this agreement, shareholders acknowledge that they understand both the risks and benefits of consuming raw milk and are responsible for their own decisions.

Guarantee

Abbott Farms guarantees to provide each shareholder with the specified quantity of fresh raw milk during the peak season and an agreed upon quantity during the off season. We guarantee that the milk will be fresh and clean when it leaves our farm. However, we are not responsible for anything that happens to the milk after it leaves our farm. Shareholders are responsible for storing milk properly in the refrigerator. Milk will naturally go sour after 1-2 weeks; please plan on purchasing the amount of milk appropriate for your household to use in a week's time.
